## State Authorization Reciprocity Agreement (SARA) Information for UNLV Continuing Education Paralegal Online Program

The Nevada System of Higher Education (NSHE) Board of Regents specifies the constitutional authority under which it was created in Article I Section I, and the institutions under NSHE include the University of Nevada, Las Vegas (UNLV). - Accuracy of information regarding any transfer of course completion information from one institution to another.
